Jonathan update – Glacier point still closed, Prescribed burns, Fire damage to the Mariposa Grove is minimal, Bridal Fall update information, Visitor Center Progress.

Rosemarie Smallcombe – Fergusson Project update

Mariposa County Board of Supervisor Update

Rosemarie Smallcombe – The Board has been discussing the housing shortage and employee shortage. Only 8.4% of the housing inventory in the county are listed as vacation rentals. Looking to see what other Jurisdictions are doing to restrict vacation rentals. There will be an item coming before the board in the next 3 weeks to approve a study of the housing situation and the effects of rentals. There is no expectation for this study to come back to the board any time before January of 2023.

Wayne Forsythe – Tennis Courts are being redone. The county has hired its first firefighters, they are part time, but they are not CalFire they are paid for by the county.

Rosemarie Smallcombe – We have been asked to move forward with enforcing existing penalties, but we need to change the language to be able to enforce the rules against illegal marijuana growths.

Vacation Rental Discussion

Douglas Shaw – There are benefits and downsides to vacation rentals, the lack of housing is exacerbating the staffing issue. Many locals have vacation rentals, why not let only locals have rentals is this within legal bounds?

Rosemarie Smallcombe – There is some precedence where there have been laws that say you may have a vacation rental only if you live in the residence so many days of the year. We are looking into the legality of certain restrictions.

Wayne Forsythe – Two-thirds of investors in homes in the county are from outside of the region. This causes those who work in the area to be priced out. The cost of building homes is very high and makes the return on investment almost negligible. The past year we built forty-nine units and lost one hundred. Of those properties nine were rentals.

Kim Brisack – Many rentals here are luxury homes, these would not be the types of residences people would be living in as a long term rentals while working in the area. Have Hip camps been discussed? They are less expensive to build and get running. They bring in ToT without affecting Housing Availability.

Rosemarie Smallcombe- Tiny homes are another thing that has been discussed. However the infrastructure is not here at the moment and getting it the costly part.

Candy O'Donel Browne – The Study is a good idea. Currently with the prices of materials, permits and fire requirements, if you build you will have to sell it for less than what you paid to build. How do we reward people for building homes in the area that we desperately need? The only way I can see is by allowing them to turn those homes into vacation rentals to make back some of their investment.

Ellen Bergstone Wasil – Income from rentals should be included in the study, that information can help show how often the rentals are being used and how many houses are just sitting vacant.
