Scott Gediman – We had the strike gold trip a week ago. It was with a great group. One if not the best FAM trips we have done ever. What stuck with me was how we all worked together. The FAM trip was phenomenal. Glacier Point opened Tuesday, however we were able to take the group up to Glacier Point prior to its opening. They are working on Tioga, and it will be open hopefully in the next few weeks. The waterfalls in the park are amazing as well.

Jonathan Farrington – What about the shuttles for Mariposa Grove?

Scott Gediman – The shuttles should be up and running any day. There was a delay because of paperwork submissions. There has been some treework which has caused some traffic delay, but this will finish this week.

Jonathan Farrington – There used to be funding that helped with the program for people to get passes at visitor centers but that ended some time back.

Scott Gediman – Part of the issue with that is budget and also a personnel issue.

Jonathan Farrington – It is a ranger doing transactions, so a ranger would need to be present at the visitor's center.

Tony McDaniel – Is there concern about flooding due to snowmelt like last year?

Scott Gediman – There are no concerns, I looked at the river level just today and it is at a very safe level.

There was a conversation amongst the board members on the current state of the lodging industry.

Christian Mueller – Two to Three months ago I was worried, but we have been taking reservations like there is no tomorrow.

Scott – We are sitting above 70% even midweek. Our booking window has been short.

Ron – I haven't spoken to many of my peers, but we tend to get booked further out. We did well in the beginning of the year, and it is slowing down. Around 75% of our bookings are international.

Kevin – The view is about 70% occupancy and cedar is a bit less.
